The following represents the flow and structure of each zone as it will be changed as a result of this project.

Section 3.XXX XXXXXXXXXX Zone

A. Purpose

B. Uses Permitted Without Review
The following uses may be allowed on lands designated XXX without review.

1. Utility Facility Service Lines under 200' in height.

C. Uses Permitted Subject to Ministerial/Type I Review
The following uses and activities may be allowed subject to a Ministerial/Type I Review on a legal parcel designated XXX subject to the Subsection XXX - Property Development Standards, Chapter 10 - Fire Safety Standards and any other listed standards.

This review involves an evaluation by Planning and Development staff but only requires formal zoning approval if the use is required to meet building codes approval. If the use does not require formal zoning approval but that is requested by the applicant for future documentation they will be charged the appropriate ministerial review fee.

1. Non-commercial/stand alone power generating facilities and Meteorological Towers Subject to Section 19.XXX. Small scale commercial power generating facilities may be allowed under this provision if allowed by Section 19.XXXX.
2. Buildings less than 200 square feet in area and less than 10 feet in height.

D. Uses Permitted Subject to Standards/Type II Review
The following uses and activities may be allowed subject to a Type II Review on a legal parcel designated XXX subject to the Subsection XXX - Property Development Standards, Chapter 10 - Fire Safety Standards, as well as any other listed, referenced or applicable standards.

1. Non-commercial/stand alone power generating facilities and Meteorological Towers Subject to Section 19.XXX. Small scale commercial power generating facilities may be allowed under this provision if allowed by Section 19.XXXX.
2. Electrical Transmission Facilities Under 200' in height subject to Subsection J(8) (ORS 215.275 Utility facility standards)

3. Utility Facilities necessary for a public service subject to Subsection J(8) and the applicable provisions of Chapter 20, Site Plan Review if the use will include off street parking.

E. Conditional Use Review/Type II or Type III

The following uses and activities may be allowed subject to a Type II or Type III Review on a legal parcel designated XXX subject to Subsection XXX - Property Development Standards, Chapter 5 – Conditional Use Review, Chapter 10 - Fire Safety Standards as well as any other listed, referenced, or applicable standards.

1. Non-commercial/stand alone power generating facilities and Meteorological Towers Subject to Section 19.XXX. Small scale commercial power generating facilities may be allowed under this provision if allowed by Section 19.XXXX.
2. Commercial Power Generating Facility (Utility Facility for the Purpose of Generating Power) subject to Section 19.XXX, and the applicable provisions of Chapter 20, Site Plan Review if the use will include off street parking.
3. Utility Facility Service Lines over 200' in height. (This is not likely to happen so we may not want to include this. Should this also be subject to Chapter 19 or only the CUP criteria?)
4. Electrical Transmission Facilities over 200' in height & Natural Gas or Petroleum Product Pipelines subject to Section 19.XXX, and the applicable provisions of Chapter 20, Site Plan Review if the use will include off street parking. (This includes towers which are described in ORS)
