NOW ON THIS DAY, the above-entitled matter having come on regularly for consideration, said day being one duly set in term for the transaction of public business and a majority of the Court being present; and

IT APPEARING TO THE COURT: That on June 26, 1983, Wasco County adopted by ordinance the City of The Dalles Comprehensive Plan and implementing ordinances for land lying within the urban growth area, and has previously entered into an (amended) urban growth area Joint Management Agreement with the City, which requires that plans and implementing ordinances be coordinated within the urban growth area (outside city limits and inside the urban growth boundary); and

IT FURTHER APPEARING TO THE COURT: That on April 22, 1993, the City of The Dalles Planning Commission reviewed and recommended the City Council approve the Final Periodic Review Order. The City Council of the City of The Dalles then considered the "Final Periodic Review Order" amendments and approved the final Order on May 3, 1993, and thereafter forwarded that decision to Wasco County; and

IT FURTHER APPEARING TO THE COURT: That on December 1, 1993, at 11:15 a.m., in the County Courtroom of the Wasco County Courthouse, The Dalles, Oregon, this Court met to conduct a public hearing on the above matter as the members of the Court were determined to be qualified to hear the matter;


IT FURTHER APPEARING TO THE COURT: That the Court took notice of the record, heard the Staff report and then requested testimony and evidence from interested parties, only the proponent spoke. The Court then announced it would deliberate, and based upon the evidence and findings of fact, the County Court, being fully apprised in the premises;

NOW THEREFORE THE WASCO COUNTY COURT DOES HEREBY ORDAIN AS FOLLOWS: By a 3-0 vote of the County Court of the County of Wasco, State of Oregon, the proposed City of The Dalles Final Local Periodic Review Order, herein attached hereto and by this reference incorporated is adopted and found to be consistent with the Joint Management Agreement previously entered into between the City of The Dalles and Wasco County.


